# **NOTIFICATION OF DISCLOSABLE PECUNIARY INTERESTS**

## **EXPLANATORY NOTES**

You must complete this form and return it to the Council's Clerk within 28 days of your Council's adoption of a new Code.

If you subsequently disclose at a meeting an interest which you have not previously registered, you must notify the Clerk of the details of that interest within 28 days of that meeting

Any interests notified on the attached form or subsequently to the Clerk, will be included in the Register of Interests. A copy of the Register will be available for public inspection and the information in it will be published on the Parish/Town Council's web-site (if it has one) and on Wyre Council's website.

It is a criminal offence knowingly or recklessly to provide information that is false or misleading.

If you are in doubt about whether or not something should be declared, you are urged to err on the side of openness and avoid not registering something in error.

In this form, the following definitions apply:-

***"body in which the relevant person has a beneficial interest"** means a firm in which the relevant person is a partner or a body corporate of which the relevant person is a director, or in the securities of which the relevant person has a beneficial interest;*

***"director"** includes a member of the committee of management of an industrial and provident society;*

***"land"** excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income;*

***"relevant authority"** means the council of which you are a member;*

***"relevant period"** means the period of 12 months ending with the day on which you notify a disclosable pecuniary interest;*

***"relevant person"** means you or your spouse or civil partner, a person with whom you are living as husband and wife, or a person with whom you are living as if you are civil partners;*

***"securities"** means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.*

If you consider that the disclosure of the details of a disclosable pecuniary interest could lead to you, or a person connected with you, being subject to violence or intimidation, you should contact the Monitoring Officer. If he agrees and, if the interest is entered on the register, copies of the register that are made available for inspection and any published version of the register will exclude details of the interest, but may state that you have a disclosable interest, the details of which are withheld under Section 32(2) of the Localism Act 2011.
